Terms & Conditions

1	Term 1 is from April to September and Term 2 is from October to March.
2	Books, Uniforms and Medical Expenses are not included in the above.
3	An Imprest amount of Rs 20,000 for petty cash expenses may be deposited with The Accounts Office.
4	Breakages and damage to School property, wilful or otherwise, is not included.
5	The above only includes basic medical expenses provided in-house like dressings and OTC type medicines for immediate relief. All medical expenses incurred outside the School towards Doctors, Hospitalisation, Medicines etc will be borne by the Parent. If the student is covered by Medical Insurance, the same may be provided to The School Office.
6	A charge of Rs 500 is applicable for dishonoured cheques and 2 such defaults will result in The Accounts Office not accepting Cheques in future, and instead will only accept online transfers/cash.
7	The Tuition & Boarding Fee shall be charged for 12 calendar months (April - March) in a session.
8	3 months notice shall be given in case of any withdrawal failing which school will charge fee for 3 months in lieu.
9	If the Fee Due exceeds 30 days or all Security Deposits (if applicable) with the School, the student's name will be removed from the School Roll.
10	Students wishing to continue study at DGS after removal from the School Roll for any reason, would need to apply afresh.
11	Fee is subjected to approx 10-15 % upward revision per annum.
12	The school reserves the right to review the fees periodically and the same shall be applicable to all students.
13	The Parent is expected to read and understand all the Policies of the School prior to taking Admission.
14	The refund/adjustment/transfer of the fee once paid will be on a case to case basis depending upon School policy.
15	All disputes shall be subject to competent courts having exclusive jurisdiction in district of Dehradun.

Other Terms and Conditions

16	Annual Function charges of Rs 500 to be collected annually in August.
17	School Magazine charges of Rs.350 to be collected annually in October.
18	ID card Fees of INR 50 to be collected annually in July.
19	Please note that the CBSE Board fee is payable in month of August/September for grade 9,10,11 and 12 registrations.
20	Alumni membership charge of Rs. 500 will be charged at the time of withdrawal.
21	An administrative charge of Rs. 50 will be charged for the T C at the time of withdrawal.
