Terms & Conditions

1	Books, Uniforms and Medical Expenses are not included in the above.
2	Breakages and damage to School property, wilful or otherwise, is not included.
3	The above only includes basic medical expenses provided in-house like dressings and OTC type medicines for immediate relief. All medical expenses incurred outside the School towards Doctors, Hospitalisation, Medicines etc will be borne by the Parent. If the student is covered by Medical Insurance, the same may be provided to The School Office. For any visit to a Doctor/Hospital other than the empanelled one, transport and guardian arrangements will be made by the Parent after due approvals are taken.
4	A charge of Rs 500 is applicable for dishonoured cheques and 2 such defaults will result in The Accounts Office not accepting Cheques in future, and instead will only accept online transfers/cash.
5	A Late Fee fine of Rs. 50.00 per day shall be levied from the 11th day of each month, unless there is prior approval.
6	Fees shall be charged for 12 calendar months (April - March) in a session.
7	The Fee is paid as per the School Prospectus and Parents should not expect bills or reminders.
8	30 days written notice of withdrawal shall be given to The School Office, failing which a months fees will be charged in lieu.
9	If the outstanding fee exceeds 45 days plus all Security Deposits (if applicable), the student's name will be removed from the School Roll.
10	Students wishing to continue study at DGS after removal from the School Roll for any reason, would need to apply afresh.
11	Fee is subjected to approx 10-15 % upward revision per annum.
12	The school reserves the right to review the fees periodically and the same shall be applicable to all students.
13	The Parent is expected to read and understand all the Policies of the School prior to taking Admission.
14	All disputes shall be subject to competent courts having exclusive jurisdiction in district of Dehradun.
15	For students seeking direct admission to Grades 10/12, there will be an Academic Remedial charge based on an Assessment.
16	The refund/adjustment/transfer of the fee once paid will be on a case to case basis depending upon School policy.

Other Terms and Conditions

17	Transport charges are extra as applicable and will be paid for 3 months at a stretch.
18	Annual Function charges of Rs 500 to be collected annually in August.
19	School Magazine charges of Rs.350 to be collected annually in October.
20	ID card Fees of INR 50 to be collected annually in July.
21	Please note that the CBSE Board fee is payable in month of August/September for grade 9,10,11 & 12 registrations.
22	Alumni membership charge of Rs. 500 will be charged at the time of withdrawal.
23	An administrative charge of Rs. 50 will be charged for the T C at the time of withdrawal.
