TERMS & CONDITIONS

1	Books, Uniforms and Medical Expenses are not included in the above.
2	Breakages/Damage to School property by students, wilful or otherwise, is not included, and will be charged.
3	The fees include basic medical provided in-house like dressings and OTC type medicines for immediate relief. All medical expenses incurred outside the School towards Doctors, Hospitalisation, Medicines etc will be borne by the Parent. For any medical emergency, the student will be taken to Subharti Hospital, located beside the School, while simultaneously informing the Parents.
4	Rs 500 will be charged for dishonoured cheques. The School will only accept online transfers/cash, thereafter.
5	A Late Fee fine of Rs. 50.00 per day shall be levied from the 11th day of each month, unless there is prior approval. For prior approvals, Parents must approach the School before the 10th of the month in which the default occurs.
6	Fees shall be charged for 12 calendar months (April - March) in a session.
7	The Fee is paid as per the School Prospectus and Parents should not expect bills or reminders.
8	30 days written notice of withdrawal to be given to The School Office, failing which a months fees will be charged.
9	If the outstanding fee exceeds 60 days, the student's name will be removed from the School Roll. Students wishing to continue to study at DGS after removal from the School Roll for any reason, would need to apply afresh.
10	The Parent is expected to read and understand all the Policies of the School prior to taking Admission.
11	All disputes shall be subject to competent courts having exclusive jurisdiction in district of Dehradun.
12	There are no refunds for fees once paid. All requests will be considered on a case to case basis depending upon School policy.
13	Transport charges are paid quarterly and levied for 11 months in the year.
14	Annual Function charges of Rs 550 to be collected annually in August.
15	School Magazine charges of Rs.350 to be collected annually in October.
16	ID card Fees of INR 50 to be collected annually in July.
17	Please note that the CBSE Board/Registration fee is payable in month of August/September for Grade 9,10,11 & 12 registrations.
18	Alumni membership charge of Rs. 500 will be charged at the time of withdrawal. An administrative charge of Rs. 50 will be charged for the T C at the time of withdrawal.
19	School messaging is done on the AES app and all Parents must download the app and understand its working. Parents must also be comfortable using the Internet, or having someone to assist them for this.
20	The fees include Grade 11 membership and participation in the NSS which is compulsory.
21	The fees include Career Counselling for Grades 10,11,12 students.
22	The fees include 24 issues of digital subscription of The Junior Age magazine for Grades 3 - 9.
23	An Imprest amount of Rs 20,000 for petty cash expenses may be deposited with The Accounts Office, for boarding Students only.
24	Fee is subjected to approx 10-12% upward revision per annum.
25	The school reserves the right to review the fees periodically and the same shall be applicable to all students.
